#### **MINUTES**

#### Annual General Meeting—September 10, 2008

President Carolynne Canham called the meeting to order at 7:06 p.m. and welcomed approximately seventy members and guests to the 55th Annual General Meeting of Niagara Support Services. This year's meeting was held at the Americana Conference Resort, 8444 Lundy's Lane, Niagara Falls, Ontario.

All voting members received a folder that included the NSS Annual Report, financial statements for the year ended March 31, 2008, and a voting member card.

The President put forward the following motion:

To consider the recommended amendment to the Bylaws of the Corporation on this 10th day of September 2008, and if approved, that the Corporation is hereby authorized to amend the organization's bylaws by adding paragraph number 2J to Bylaw No. 1, General Bylaw of the Association, Section: Board of Directors, as follows:

The Board of Directors may, at its sole discretion, bestow the title of Honourary Board Member upon a past or retiring board member of the organization. The Honourary Board Member may attend any meeting of the directors in an advisory capacity only, at the invitation of the president or designate, and shall not have a vote on issues or questions arising at any such meeting of directors.

All in favour – Carried.



## Report from the Chief Executive Officer



In a world that rarely stops to take a breath these days, it is sometimes difficult to reflect on the highlights of a specific year gone by. A year is a fixed period of time, and so much of what we do at Niagara Support

Services is an ongoing, continuous, fluid process. Although I can report to our membership about structural and capital changes that occurred in a given reporting year, I know that it is the enduring and ongoing processes and personal successes, which transcend fiscal years, that become the fabric of our agency and the stories of which we can all be proud.

On the capital improvement front, there were two significant and visible additions this year. The first was a new roof on the Donald L. Reilly Centre on Sinnicks Avenue in Niagara Falls. While this facility is actually owned by our partner agency, Niagara Training & Employment Agency (NTEC), it is home to Niagara Support Services' Children's Residential Program, our Children's Autism Program (a.k.a. CAP Class), and our CEVS office. While the old flat roof on the former elementary school has served its time well, I would suggest that the most significant aspect of that renovation was the marked transformation of a building from its former institutional façade, to one with more residential community appeal, courtesy of a new pitched steel roof.

The second major capital improvement to occur in the 2008/09 fiscal year was the construction of an elevator at our Longhurst Avenue facility in Niagara Falls. Home to our Community Skills and Intervenor programs, our Manager of Day Services, as well as a host of evening activities, trainings and meetings, the former Firehall will now have much enhanced accessibility to the second level. This will allow our agency, which is of course rooted in Niagara Falls, to host more events closer to home for many of our families and program participants.

As many of you are aware, the Developmental Services Act (DSA) is being replaced by The Services and Supports to Promote the Social Inclusion of Persons with Developmental Disabilities Act, 2008. The Ministry of Community and Social Services, or MCSS, is at long last repealing the standing legislation that enshrined in law such things as institutional life for people with developmental disabilities. As society has changed over the past three decades, the need for updated legislation to guide the actions of those who are involved in developmental services became very apparent. The government has stated that it wants to improve services and supports for people who have developmental disabilities and their families. The process of enacting new legislation is long and involved, and it will be some time before we fully experience the contemplated

changes. We are pleased that the Ministry is engaging in consultations with agencies and families alike to hopefully ensure that the interests of the people we support are represented. I would further suggest that the new legislation will not only open up new opportunities for individuals, but will also see changes to help support the solid agency system of which we are a part.

In the 2008/09 year, we also made significant strides in the area of assurance of personal rights for our program participants. Niagara Support Services has been involved in the 3Rs research project, which encompasses *Rights* training, combined with *Respect* and *Responsibility*. As the research component draws to an end, you can be assured that our agency is looking for ways to ensure and protect the rights of individuals in our service.

Niagara Support Services has also continued to invest in our commitment to Corporate Social Responsibility. Continued energy efficiencies are being sought each time we undergo a renovation or improvement, and we also continue to partner with NTEC in the promotion of other environmental and socially responsible projects.

As we look toward the future in the Developmental Services realm, we can be daunted by the seeming never-ending need for resources in an economic climate that has come to see its limits. At the same time, we are sustained by the hope of a continuously evolving sector in the world of the Developmental Services Transformation. We can see a future that is more equitable, more flexible, more portable, more transparent, and more individually focused. While we realize that the Transformation will not happen overnight, we can rest assured that the true interests of the individuals who access our services will be better served in the transformed sector.

In the meantime, while the sector continues its transformation, and new legislation is drafted and enacted, I would maintain that the outstanding quality of services and supports that the employees of Niagara Support Services provide to the individuals in our service is not dictated by our legislation or its regulations. The significant contributions made in the lives of the people we support are due wholly to the skills, talents, and dedication of our *professional*, caring and inspired team.

The coming year will no doubt again be filled with challenges and trials and the promise of great things to come. Thank you for being a part of this agency's journey.
